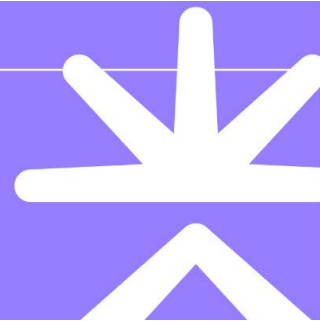

Under NZ legislation, Helia Insurance Pty Limited (Helia) is required to maintain a solvency margin which pursuant to an exemption granted by the RBNZ is calculated in accordance with Australian solvency requirements.

Please refer to the updated solvency info for Helia as at 31 Dec 2022 (using RBNZ published exchange rate AUD = 1.062 NZD).

Helia's solvency disclosures as at 31 Dec 2022, and as lodged with the RBNZ in its half year solvency returns, are detailed below:

Actual capital base: \$AU 1,795 million (\$NZ 1,907 million)

Prescribed capital amount: \$AU 848 million (\$NZ 900 million)

Capital in excess of prescribed capital: \$AU 947 million (\$NZ 1,007 million)

Prescribed capital amount coverage: 212%

An overseas policyholder preference applies. Under Australian law, if Helia Insurance Pty Limited is wound up, its assets in Australia must be applied to its liabilities in Australia before they can be applied to overseas liabilities. To this extent, New Zealand policyholders may not be able to rely on Helia's assets in Australia to satisfy New Zealand liabilities.
